Our mission is to empower participating Cambodian villages in becoming self-sustaining communities where people want to live, with year-round healthy water and facilities, good food, health care and education for the residents, where there is environmental and social responsibility, including education opportunities for their children from preschool through grade school and university, and where families have training and employment opportunities that allow them to sustain and continually improve their quality of life.

Community Development Programs provided training and support in 3 key areas: Safe Water, Food Security and Income Generation. Among the Safe Water projects, 138 BioSand Filters were installed to remove dirt, bacteria and viruses from drinking and cooking water in ten villages to serve 1,206 people. 6 Deep Water Wells and 1 Multi-Use Well were installed to provide year-round water in five villages to serve 783 people. 32 new Rooftop Rainwater Harvest tanks now capture the wet season's ever abundant rainwater for 91 families in 12 vilalgles through gutter systems that pour rainwater into a 4,000 liter sealed tank with a spout at the base. Among the Food Security Projects, the Community Rice Banks collected 39,127 kilograms of rice in 6 villages to benefit 1,717 people. 10 new Community Ponds support 116 families with 991 people by capturing rainwater in wet seasons for washing, irrigating gardens, and caring for livestock. Agricultural Training benefited 180 people with seeds for Vegetable Gardens and increased the confidence of the communities to feed themselves. Income Generation Projects focused on the development of 29 Self-Help Groups of 430 families. Each group member is responsible for developing their own business plan. Together, the Self Help Groups applied for a microloans and learned how to monitor and build their businesses. Finally, Animal Pass-On Projects provided 39 families of 216 people with 7 cows, 3 buffalo, 30 ducks, 85 chickens, 2 geese and 6 pigs to build and expand income generation opportunities for communities.

Our Sustainable Education Program is the foundation of our organization and may be the most lastingly sustainable opportunity for the families. Current Education Programs include 16 Village Preschools that create a learning environment for 317 young children and Village Primary Schools provided 436 children in rural villages access to previously inaccessible education in numeracy and literacy. The Sylvia Lasky Memorial School, Kravanh Bright Future Center and Kandieng Sustainable School offered 953 school-aged children in grades one through twelve supplementary courses to expand their understanding of English, Khmer Language, Math, Computers, and special tutor classes in Physics and advanced Math. Additionally, our students study Health, Hygiene, Nutrition, Human Rights along with special activities, including field study trips and cultural celebrations. School supplies for 402 students, school uniforms for 150 students and bikes for 182 students provided students with essential support to travel and participate in classroom lessons. Through Youth Club, students build leadership skills and practice organizing and hosting school-wide events. Most importantly, they plan and implement workshops in their communities to improve family understanding of health issues and the benefits of education. Scholarships for Cambodian universities advanced the educations, self-reliance and employment opportunities for 130 young people.

The Community Healthcare Program focuses on facilitating health education and training and creating Community Health Committees who monitor village health and link ill family members with medical professionals outside the community. Hygiene Training educates the community on washing of fruits, vegetables, and hands as well as on general health care, nutritional health, and basic sanitation. In addition, they are also trained in basic first aid. To supplement the material taught, SC staff also provides instructional posters and perform demonstrations. Significantly, the Village Preschool Food Supplement Program seeks to overcome the general lack of means and nutritional education of the communities to fulfill the dietary needs of the preschool children. In 2013 430 preschool children in 11 preschools received a daily supplement hot meal of dark leafy green and orange vegetables, fish and/or eggs, oil, garlic and rice. Summary health reports are created by staff every 6 months in partnership with the Community Health Committee in their monthly records of the children's health that show each child's height, weight ( BMI) any report of illness during the period. Communities are expected to contribute what they can, including surplus fish from fishponds, vegetables from community gardens, interest from micro loans and rice from the rice banks. As needed, extra funding is provided by SC, through specific grants. The average cost is about 20 cents per meal per child per day. The outcomes for the children's improved health and cognitive development are immeasurable.

Many volunteer directors oversee the individual grants whose funding they helped to build and assist. All financial documents are submitted to the external auditors.

Line 12c: Volunteer directors visit Sustainable Cambodia on an annual or semi-annual basis. During these visits, they lead all-staff meetings to review and clarify organizational policies, including Conflict of Interest and Code of Ethics. All members of the organization are required to complete conflict of interest agreements and cash-handling policies. Rotary, a large supporter of Sustainable Cambodia programs, has far-reaching influence through their explicitly required stewardship of funds and reporting procedures. Beyond the onsite visits, daily email correspondence, executive Skype and GoToMeeting calls further promote communication and clarification of daily operations.
