Our mission is to empower participating Cambodian villages in becoming self-sustaining communities where people choose to live, with year-round safe water and facilities, good and plentiful food, healthcare training and education for the residents, where there is environmental and social responsibility, economic and employment opportunities that build and improve sustainable quality of life, including education opportunities for their children from preschool through grade school and often local university degrees and jobs.

Community Development Programs provided safe water, food security and related projects in 24 villages to assist over 10,000 people. 32 new Rooftop Rainwater Catchment tanks benefit 340 people from 28 families and 6 schools by catching rainwater for daily use. 23 new Wells benefit 853 people from 148 families by providing nearby year-round water for drinking, cooking, bathing and cleaning. 139 new BioSand Filters benefit 696 people from 139 families by providing a home-use, self-sustaining filter unit to ensure clean water. 158 new Latrines benefit 765 people from 158 families by providing family sanitation and environmental responsibility for the villages. Home Garden Seeds benefit 615 people from 39 families by providing seeds to grow vegetables for home nutrition and market income. Agricultural trainings in Self Help Groups benefit 659 people from 161 families in planning and managing shared animals and crops. Pass-on Animals and training: 17 cows, 11 buffalo, 500 chickens, 65 ducks, 10 pigs benefit 718 people in food security and income. 6 new Community Ponds benefit 321 people from 86 families by providing water for irrigation, live stock and fish for food security. Crop Loans benefit 2,101 people from 423 families in purchasing seed, starter plants and tools during the start of planting season. Microloans benefit 1,980 people from 399 families in management training, income generation and shared community resources.

Education Programs provide foundational instruction in native Khmer literacy, Math, English, computer use, health and human rights education for 959 grade school students in 3 Pursat province schools as well as for 1,436 students in other provinces like Siem Reap. 175 Bikes benefit 175 children in traveling to our schools and to their state schools to improve their attendance and learning outcome. 200 School Uniforms and 523 packages of School Supplies improve the participation and success of our students in their classes. The TC Swartz Lunch Program benefits their outreach students whose cognitive development is challenged by under-nourishment. 16 Preschools and rural Community Schools bring Khmer literacy and numeracy and social development and local teacher training in a learning environment that would not otherwise exist without Sustainable Cambodia's community education outreach programs. Tutor classes in higher math and science classes assist our older students in passing the 12th grade state exams in order to continue their studies in Cambodian universities. In 2014, 143 scholars were enrolled in degree programs and 85 scholars had graduated. Special activities include expanded reading area, traditional Cambodian dancing classes, field study trip to cultural sites, school-wide ceremonies and events. Youth Clubs help students in managing service projects, in becoming leaders and self-reliant young adults.

The Community Healthcare Program has two main areas of focus: providing workshops in preventative healthcare and best practices, first aid training, mother and infant care, as well as supporting family training in nourishment and delivering hot nutritious meals for the preschool children in the villages. In 2014, the preschool food supplement meal program provided 460 young children ages 3 to 6 from 11 rural preschools with a daily hot meal of dark leafy greens and orange vegetables, fish and / or duck eggs, oil, garlic and rice. In addition to building the children's overall health, body mass and resistance to disease, these meals motivate the children to attend their preschool classes where they participate in activities that encourage early childhood cognitive development. To sustain the benefits of the healthcare training, Community Healthcare Committees led by village representatives monitor village health and help families with health concerns in connecting with the medical clinics in the provinces. The Committees also maintain records of the children's height and weight and report any illnesses to Sustainable Cambodia staff. In 2014, hygiene materials, including toothbrushes, toothpaste, soap, towels, buckets and clippers were provided to the children in 10 rural communities. Emergency food was also provided for the students of highest need at our Kravanh Bright Future Center ( KBFC ).

Line 11a: Volunteer Treasurer Susan Mastin provides a copy of completed Form 990 with support schedules for the review of volunteer CEO (and CPA) Richard Allen. When possible, Form 990 is also reviewed by volunteer director Kevin Conlin who assists with financial reporting throughout the year. Prior to the completion of Form 990, Mastin leads an extensive review of accounting transactions made by onsite Cambodian Finance Manager Vorn Chanra and her team in Pursat. Sustainable Cambodia's Executive Director Phang Polin also assists with clarification of transactions through emails and regularly scheduled Skype Calls. During the year directors who are the main contacts for their individual Rotary Club's grants carefully oversee the transactions in quarterly grant reports provided by onsite grant project managers in Pursat. Additionally, all supporting financial documents and QuickBooks accounting files are submitted to the external auditors.

Line 12c: Volunteer Directors visit Sustainable Cambodia on annual trips to meet with staff, tour community projects, conduct internal audits, observe and evaluate operations and assist with training, as needed. During the all-staff meetings, Directors clarify essential organization policies, including the Code of Ethics and Conflict of Interest. All staff and board members acknowledge conflict of interest agreements and updated cash-handling policies. Rotary International has significant influence on Sustainable Cambodia's grant managers who agree to follow the "stewardship of funds" policies required by Rotary to ensure 100% transparency in the application and tracking of grant funds. Multiple Board members exchange daily emails with the onsite staff and participate in weekly Skype or GotoMeeting calls to review specific agenda topics and provide feedback and guidance, as needed.
