Sustainable Cambodia's all-Cambodian staff works with rural families and communities to build empowerment opportunities through self-sustaining programs, including instalation of wells, ponds and water catchment tanks, safe water filtration, latrines, training in agriculture, animal husbandry, self-help groups, health and hygiene, cash crop start-up loans and gardens along with enrichment education and supplies for children from preschool age with food supplement meals to grade school and university.

Community Development programs expanded further into villages in the Bakkan region with Rotary support from Western Australia. The Youthlinc Project supported the volunteerism of young people from the U.S. to assist the remote village families of Chung Ruk with a community school, pass-on animals, BioSand Filters for safe water, and training workshops and mentoring our grade schools. In the wells and water program, 5 deep water wells, including 1 deep water well for community preschool in Chung Ruk sponsored by YouthLinc, were installed. Additionally, 7 mutli-purpose wells and 1 shallow well were installed plus repairs and 30 new pvc pumps. Installation of 56 Rooftop Rainwater Harvest (RRH) water tanks capture and safely store water during the rainy season for families and schools who now have the ability to capture enough water to get through the dry seasons. Water stored in RRH is not exposed to water-borne diseases from mosquitoes. Children who no longer have to carry water from distant and polluted sources now have time to attend school. New boys and girls latrines were installed in 14 remote preschools and community primary schools with hygiene education. The Pass-On Animal program provided Self Help Group (SHG) training, 12 cows, 4 water buffalo, and 60 chickens to build economic security and help with agricultural labor. SHG training workshops and seeds also supported growth of home gardening. Cash Crop Loan program was hugely successful, lending over \$60,000 to hundreds of families who had repaid 70 % by December.

Expansions in the education program include project management for 6 additional grade schools with lunch programs through the support of an ongoing grant. Sustainable Cambodia also continued full financial support and management of the KBFC school in remote Kravanh District where more than 300 students receive supplemental education for primary grades through university. Increased enrollment of 177 new students in our main school in Pursat brings that school's population to over 400 students. Rural community preschool projects focused on repair, concrete floors, chairs and desks, books, play equipment, and rainwater catchment. All grade schools provide enrichment education in English, Computers, Math, Khmer Language, school supplies and bikes for the children from families of highest need, health education, and field study trips to culturally important sites like Angkor Wat Temples. In 2012 the university scholarship program added 46 new scholars in pursuit of degrees for a total of 128 scholars now actively attending Cambodian universities in Pursat, Battambang and Phnom Penh. International volunteers added a music program with guitars and keyboards, a swimming program to empower young people with life-saving skills and enjoyment. The preschool nutritious food supplement program continues to fortify our youngest learners with a hot breakfast in an engaging and interactive learning environment to prepare them for grade school.

Healthcare Education program primarily oversees the Preschool Nutrition Program, First Aid Kits, and Community Health Workshops. By the later part of the year, the Preschool Food Supplement Program grew to feed over 450 children every day in 12 remote villages. Again in 2012, volunteer nurses visited the preschools to study the children's health and to document the Body Mass Index for all the children participating in the program. The overall data is encouraging with fewer than 10 children under special review. Healthcare workshops focused on health and hygiene education for children and families on safe water, tooth brushing and hand-washing and demonstrating the use of First Aid Kit supplies for first aid. Healthcare team also works with families on how to identify and prevent health concerns in small children like dehydration from chronic diarrhea.
