Our mission is to empower rural Cambodian community families to identify their highest needs. Our all-Cambodian staff partners with the families to implement sustainable projects and economic opportunities, including agriculture training, supplies, wells, ponds and catchment systems, biosand filters, latrines, pass-on animals, roads and healthcare education to improve their quality of daily life. Our staff also provides education opportunities for children from preschool through grade school and often local university degrees.

Community Development Programs helped community families in 20 villages to improve their lives through training in agriculture and economic opportunities and healthcare, including the installation of the following:  
5 Community Ponds excavated to create water catchment in rainy seasons to assist families with fish, irrigation for gardens / animals  
34 Rooftop Rainwater Harvest tanks to assist schools and families by capturing and storing rainwater safely in large covered tanks  
11 wells (deep, multi-use, shallow) to provide groups of families in sharing water for daily use throughout the rainy and dry seasons  
124 BioSand Filters to assist families in removing the impurities from their well water for safe use in drinking, cooking and bathing  
162 Latrines and sanitation training to provide community families with improved opportunities for better health and sanitation.  
4 Cows and 125 Chickens to provide 29 families with improved nutrition and economic opportunities through use of farm animals  
16 Trainings in animal raising and vaccinations to assist families in caring for their animals, especially cows and buffalos  
1,500 meters of road construction in Prey O'mal to provide families and children the opportunity to reach markets and schools  
Agricultural Trainings in creating compost and home gardens, and provision of seeds and tools and fences  
Introduction of Cricket farming to improve nutrition and economic opportunities

Education Programs to provide primary students instruction in native Khmer language, Math, English, and basic interactive computer programs and library reading activities to expand literacy, cooperative and independent learning. We also provided more advanced English classes and computer classes, for a total of 836 students in three Pursat area schools. In areas near Siem Reap, we oversaw supplemental classes in six schools for approximately 1,400 students. In these provinces, daily nutritious meals were provided for 459 children from families in highest need. Overall, Sustainable Cambodia creates enriched learning school environments with school gardens, dance and art, libraries, cultural celebrations, Youth Clubs that build leadership opportunities. Special support in math and science tutor classes help 12th graders to pass the state exams and to move forward to pursue degrees in Cambodian universities and improve their employment opportunities. In 2015, 40 new scholars began their university studies, for a total of 110 active scholars. Additional benefits included 111 bikes to help students travel to school; 570 book bags, 386 school uniforms and school supplies to help students feel confident and to be successful participants in their classrooms. One new preschool was built in Thmor Beydom (with a latrine) to expand our existing preschool program support for approximately 450 rural children, ages 3 - 6.

Our Healthcare Programs have two main projects: community trainings in preventative healthcare and best practices in hand-washing and first aid, first aid kits, maternal and infant care; education in nutrition and delivering of daily hot nutritious meals for preschool children. In 2015 these porridge meals of leafy greens, carrots, fish / duck eggs, rice, oil and garlic nourished 149 young children from 4 preschools in building their immune systems, energy, cognitive development and growth in height and weight. Many families are motivated to bring their children to preschool primarily for the benefit of these meals. Once there, the children stay to participate in language development and math activities. They also grow socially in preparation for their future formal schooling. Community Healthcare Committees led by village representatives look after families, assist them in traveling to local health centers for diagnosis and care. When needed, Sustainable Cambodia provides emergency assistance for families devastated by floods and our school teachers follow student health and intervene, as needed, with special transportation and funding to visit doctors for care. In all our schools and preschools, students practice hand-washing and sanitation and learn about the importance of clean water, nutrition and staying healthy.

For 2015 while onsite in Pursat, Mastin also conducted an internal audit utilizing statistical sampling techniques and methods from generally accepted accounting standards. She determined that the onsite finance team carefully followed accounting and cash handling procedures to ensure tracking and reporting of accurate revenue / expenses by programs. Throughout the year, directors who are the main contacts for individual Rotary Club grants connect through scheduled calls to clarify activities with the onsite Cambodian project managers with Sustainable Cambodia.

Line 12c: Volunteer Directors regularly visit Sustainable Cambodia's Pursat offices to meet with staff, tour community projects, observe and participate in trainings and clarify Code of Ethics and Conflict of Interest policies. During all-staff meetings throughout the year, the Executive Staff also leads instruction and confirmation of compliance with these policies. In the event of any questions, the Executive staff contacts Directors for assistance, follow-up communication and resolutions.

Line 19: Sustainable Cambodia posts on its website: Forms 990, financial statements, audits and compilations, grant reports, annual reports, policies and program guides along with volunteer guide, newsletters, powerpoint and presentations to assist supporters and to share with non-profit organizations that deliver similar programs. Upon request, we also provide these documents by postal or email.
