Our mission is to support our all-Cambodian staff in empowering families in rural Pursat villages to identify their own highest needs and to coordinate their own Community Development groups and Self-Help Groups to implement extensive programs that improve and sustain their lives. Programs include Safe Water Systems and Latrines, Biosand filters (BSF) Rooftop Rainwater Tanks (RRH), Agricultural, Economic opportunities, Health Care and Enrichment Education for children from preschool through graduation.

4a (Code: Com Devel) (Expenses \$ 138,181 including grants of \$ 5,090) (Revenue \$ _____)
Our Safe Water and Hygiene program (WASH) is a critical centerpiece of our community development strategy. Given the essential benefit of water to support well-being in village life, the presence of nearby, year-round safe water provides food security, healthcare, agricultural and economic opportunities. Walking to a nearby well to collect their family's water also gives children precious time to attend school. Water cleaned through a family's BioSand Filter reduces contamination and life-threatening water-borne diseases. In 2019 COMMUNITY DEVELOPMENT PROGRAM ACCOMPLISHMENTS INCLUDED:
53 BioSand Filters serve 267 people. The concrete BSF filled with sand and gravel removes bacteria, viruses, parasites, impurities. 8 Water Wells serve 184 people. Easily accessible water (pumped from safe below-ground sources) lasts through long dry seasons. 27 Rooftop Rainwater Harvesting Tanks serve 916 people. RRH (a concrete sphere) captures and stores rainwater from a family's roof. 31 Family Latrines improve hygiene for 107 people, including reduced contamination from human waste otherwise in water supplies. 5 Trainings in Agriculture with 48 Participants provide seed, food security and effective, best practices for 30 families with 73 people Self-Help Groups and Pass-on Animal that empower and benefit families. Animal Offspring continue to provide far-reaching benefits. Victory Gardens demonstrate best techniques to raise organic vegetables through good seed, integrated water systems and compost.

4b (Code: Education) (Expenses \$ 343,745 including grants of \$ _____) (Revenue \$ _____)
In 2019 our EDUCATION PROGRAM continued two main components: Supplemental and Enrichment Classes for 642 students from high need families in 33 Pursat villages. The aim of Supplemental Classes is to strenghten the ability of our students to advance to the next grade level (through graduation) in their state schools. These extra tutoring classes & lessons focus on Math, Physics, Biology, Chemistry and Khmer Literature. The aim of the Enrichment Classes is to expland both academic and relevant knowledge and skills through learning activities that include language arts in English and Khmer, Math, Library Time, Computer Research Time, traditional Cambodian dance and leadership growth and community service through self-directed Youth Programs. In addition, our program supports supplemental and enrichment classes located in 6 more state schools for 1,815 students. Our school learning environments encourage student well-being through creative, specially trained teachers, art, playgrounds, sport areas, latrines, wells & safe water. 7 Preschools in 2 districts provide daily nutritional meals and interactive learning programs for 158 village children from ages 3 to 5. Their activites include numbers, Khmer and English alphabets, drawing, singing and social interactions that prepare them for primary school. Our University Scholar Program provides guidance and tuition support for young people to pursue their bachelor degrees in Cambodian Universities. To date 338 scholarships have helped to lauch the work lives of young people who are rebuilding Cambodia.

4c (Code: Healthcare) (Expenses \$ 28,063 including grants of \$ _____) (Revenue \$ _____)
In 2019 our HEALTHCARE PROGRAM led 17 trainings in dental health, hygiene and handwashing in 3 communities to benefit children. There were 533 villagers (mostly mothers) in attendance. The training focuses in the importance of brushing teeth, rinsing mouth with water, washing hands and nails thoroughly with soap and rinsing afterwards with clean water. That is key to clean hands. Our Preschool Nutritional Food Supplement Program provided daily meals for 158 children in 7 preschools. Food Supplement is the morning breakfast cooked by the village mothers with special ingredients to promote high nutrition; for example, carrots, greens, oil, fish, egg, rice, spices for taste. This hot meal helps the children to attend regularly, grow healthy and enjoy early education learning. Our Days for Girls (DfG) team provided 8 trainings in understading menstrual health in 5 secondary schools to benefit 282 girls. Importantly, we distributed 350 Days for Girls Kits with menstrual cycle supplies. These sustainable supplies encourage our girls to attend school regularly during their monthly cycles, to keep up with their studies and to save money on disposable supplies. Durign the school year, we also supported emergency needs of students through food supplies and special medical assistance in health crises.

In July 2019 Sustainable Cambodia (SC) transferred \$5,090 to a non-governmental organization named Clear Cambodia, chartered and based in Phnom Penh Cambodia. The transfer was requested by longtime SC donor named Kleine Hilfsation EV, a registered charitable organization in Germany. Kleine Hilfsation learned of a school in high need of safe water and hygiene facilities. After years of working with SC to install similar facilities, they reached out to SC's experienced Community Development Team to assist Clear Cambodia in delivering this project. Kleine Hilfsation included an additional \$5,090 in the annual funds donated to SC to oversee their long-standing grant projects in education and community development. The amount of the grant for \$5,090 was based on SC's experienced calculations in creating detail budgets for specific projects like safe water and hygiene facilities.

At the beginning of the project, Sustainable Cambodia and Clear Cambodia entered into a Memorandum of Understanding (MOU) to define the agreements and responsibilities of each group in the funding payments and the coordination of onsite school committees to monitor the construction of all school WASH facilities. WASH stands for Water and Sanitation Hygiene.

During annual onsite "Rotary Journey to Cambodia" trips, visiting Board members and officers interact at length with the executive team to

strengthen leadership and project management skills along with internal organizational culture, vision and team-building. Almost daily email

correspondence connects us in collaborating on shared projects, planning and follow-up reports for grantors. As an empowerment group, we

encourage our teams to develop their own problem-solving and thoughtful decision-making. Annual staff meetings address governance

policies, including Conflict of Interest, Code of Ethics and "Sacred Trust of Funds," a practice inspired by Rotary grantors.
